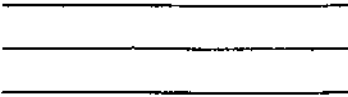

POWER COMM LINES SURVEY

Your help is needed on a very important project that will greatly assist the Church in accomplishing the continued and rapid expansion of Scientology® internationally.

The data that you give here is for Office of Special Affairs use only, and those whose names you give us will not be contacted by anyone without going via you. For this reason, the questionnaire does not ask for street addresses or phone numbers of any of the people you list.

The questionnaire follows a specific sequence: (a) basic information about yourself, (b) basic information on your power comm lines, and then (c) information on who your power comm lines know.

Below are examples of the kinds of comm lines that would be of assistance to the Office of Special Affairs:

POLITICAL LINES: Political figures on a local, state or national level, such as local city officials, mayors, governors, senators (state and national), congressmen, government agency officials and civil servants.

MEDIA LINES: Any media terminals that you know, such as owners or proprietors of magazines, newswire services, newspapers or publishing houses, TV and radio networks or stations, advertising agencies or PR firms, and publishers, editors or general managers of any type of news media.

LEGAL LINES: Any judges, law enforcement officials, lawyers, barristers, etc.

FINANCIAL/CORPORATE LINES: Members of the board of directors or presidents, vice presidents or other senior officials/executives within any major corporations or within banks or other financial institutions (such as savings and loans companies, credit unions, etc.); financiers (this could be government or private industry), stockbrokers, financial advisors, and commodities brokers.

ENTERTAINMENT/CELEBRITY LINES: Producers or directors in stage, motion pictures or television; actors, artists, writers and any opinion leaders in these areas.

OTHER OPINION LEADERS: This would include anyone who is respected by or who influences the opinions of individuals in any of the above, or related, categories.

Please be as complete as possible in filling this out. It is also important that you print your answers clearly and legibly.
