FRANCE INVESTIGATIONS HANDLING PROGRAM

INFORMATION

About mid-May the Nice mission as well as 3 other missions and groups in Marseille were raided, staff were arrested and interrogated by the police and 5 staff were charged with fraud and illegal practice of medicine. 4 of those are still kept in jail (Xavier Delamare, Emmanuelle Aulagnier, Sylvie Musset, Marie-Ange Molina).

This investigation was prompted by about 6 penal complaints filed by ex-publics of the missions of the area, most of them being psych cases. The judge of Instruction appointed on the case is Mrs Carole Sayouz.

End of June, the Lyon mission was raided also by the police and 2 staffs arrested (Alain Barou and Corinne Medalin), charged with fraud and illegal practice of medicine. Then the mission holder (Jean-Jacques Mazier) was charged with fraud, illegal practice of medicine and involuntary homicide and is still kept in jail.

Beginning of July, the Lyon police raided Paris org, CC Paris and the personal flats of the president and the secretary of CCP with the pretext they were looking for the treasury records of Lyon mission. The president and the secretary of the CCP, the president (Daniele Gounord), the secretary, the ex-treasurer of Paris org and the DSA FRA (Jean-Paul Chappelet) were arrested. The presidents of Paris org and CCP as well as the DSA FRA were kept by the police and then charged for complicity of fraud and of illegal medical practice of medicine. The president of CCP was released and JP and Daniele are kept in jail.

This investigation is apparently related to the suicide in March 88 of Mr Vic. Mr Vic had followed 2 introductory courses in the mission at that time and was in comm with the mission holder JJ Mazier. His next step to be done was the pur If rundown. The complaint against X which had been filed by his wife at that time and had been shelved in 83, had been

Get Barrucan to file, together with his letter, all the testimonies of the OLs who witnessed in the Mrs Jew/Mrs Sects booklet case.

26. Get all the lawyers of JP and Daniele to do a big press conference in Paris to expose the whole conspiracy. Get national media coverage.

27. Get law professors ,Georges LEVASSEUR and Jacques ROBERT to write an article in national newspaper Le Monde showing that there is no ground for a case; and to make any intervention we can close them on, to get the case dismissed.

MARSEILLE

5. Based on the irregularities found in the case file - including the fact that the PC folder requests and other letters ,sent by individual Scientologists have not been put in the case folder - and any evidence of the partiality of the JOI, file a motion for transfer of the case to another jurisdiction. Get it through the Supreme Court, using the support from F10.

AMERICAN CONSULATE HANDLING PROGRAM

ATHENS

77 August 1992

PROGRAM INFORMATION:

In May 1992, a Church staff member tried to get a visa from the American Consulate in Athens, Greece. He applied several times but was denied a visa for several different reasons. The attorney was in comm with the consul there, but to no avail.

What is missing is PRO Area Control:

"The extent of one's PRO area control can be Measured at once by counting up the points one is not controlling fro* the company or org viewpoint and the points one IS controlling. This gives you a ratio like three to six or one-half.

"Example: Immigration and customs are NOT doing what we want. Agents, dockmasters and police are. Thus we have two-thirds effective PRO area control." . . .

"Now the tech to apply is a survey of all five points to find out, let us say, what they want one to be, what they want one to do, and what they want to have from one. (See FEBC tape on PR.)

"Then one surveys further to find out what problem they are trying to solve by having us be, do, have these things.

"This puts us at cause because we can now handle their misinformation, reassure their suspicions and generally increase ARC."

9. Work out a handling per this survey and implement this to gain PRO Area Control.

Should come on his lines regarding the Church or if he ever has any questions on the Church, he will call you.

11. Do a PR visit to the Athens desk at the State Department in Washington, D.C. Do anything negative on Scientology that comes up and fill the vacuum on Scientology.

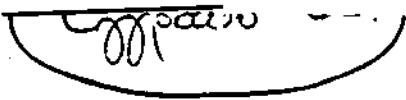

PROGRAM INFORMATION

In the last year the Greek Orthodox Church ARM activity in Greece has escalated to a level which warrants immediate attention

This recently culminated in an international ARM conference held in November 1993 where the Orthodox Church set out their intended strat to classify new religious movements as a State concern and thus force the State to partake in formulating and adopting legislation that will curtail the activities and free operation of new religious movements in Greece.

Up until now the government/State has refused to involve itself in the affairs of religions unless they break the laws of the land and to this degree they have maintained that the 'problem' of new religious movements be dealt with by the Orthodox Church as it is a religious matter.

The Orthodox Church, via their main ARM advocates, the Archbishop of Greece (Seraphim) and Pro/Sect Information I/C (Alevizopoulos), are engaged in a plan of spreading false reports and focusing attention onto new religious movements as a danger to youth and the society at large, by attempting to classify new religious movements as a social threat that needs to be addressed by the state.

This attack in Greece is being fuelled and mobilized from a foreign source point and the instigator of the Greece ARM offensives which goes as far back as the 80ies is a body in Germany definitely tightly connected/affiliated to the Lutheran Church.

This coordinated multi-bureau program is now written so as to handle this situation.

PROGRAM PURPOSE:

To get the ARM situation under control in Greece while PR activities are being created, allies are being made and legal is working out on getting the Church recognized as a religious group.

MAJOR TARGETS:

1. Alevizopoulos and Seraphim investigated with crimes exposed.
2. Interfaith activities created which will unite religious groups together making it impossible for the Orthodox Church to attack this religious body.
3. Government comm lines created so as to be able to predict future government attack on religions.
4. PR activities being done in the community and theta media being made that will DA the enemy lines about the Church and/or religious groups.
5. Religious recognition application filed

PRIMARY TARGETS:

1. DSA Greece is responsible for getting this program done.

VITAL TARGETS:

1. Do not let anything cut across the full execution of this program until the situation is handled.

2. During the execution of this program, keep coordination in

at all times with your DSA PR and with the different Invest, PR and Legal terminals at OSA EU.

3. In case of any slow or bug, get a 3 02 debug done immediately to put this program back on the rail and rolling,

OPERATING TARGETS:

1. List out the addresses and phone numbers of any religious groups in Athens and immediately start contacting these groups. Set up meetings with them and get out of non-existence. See where they stand at in regards to interfaith activities.

2. Get these meetings held on a weekly basis with at least three new allies created every week. Ensure you get referrals to Orthodox priests who we can meet with and ally and get the names of other religious leaders we should meet with in order to expand our comm lines within the religious community.

DSA PR Greece

3. Reestablish contact with Orthodox priests they have been in comm with in the past in order to get their help in handling this ARM attack, while at the same time keeping the religious groups united.

4. Once comm lines have been established with a number of groups who are interested in interfaith matters, set up the first interfaith meeting to unite the new religious movements and all advocatists of human rights/religious freedom.

5. Propose a mini-program which will firmly establish this group, and get it approved by the PR Pgms Execution Officer OSA Int., Immediately after the first meeting, set a date set for the next meeting and close a representative of each group in attendance to bring one new person to the next meeting.

6. Get a naming survey done to find a name for the interfaith

group. Get a name that would symbolize unity and openness for all religious groups.

DSA PR Greece

7. Do a positioning survey to find out what symbol would best represent this interfaith group.

DSA PR Greece

8. In coordination with the Interfaith Coordinator OSA Int, get specific terminals who have strong interfaith lines (iJordelon Melton, OPA DC [Office of Public Affairs Washington, D.C.] lines, Canada lines) briefed on the KY? report. Find anyone who has comm lines to the Patriarch of the Greek Orthodox Church to contact him and get him briefed on the anti-religious viewpoint of Alevizopoulos/Seraphim. Get his agreement to do something to handle them.

9. In coordination with the Interfaith Coordinator OSA Int, get allies internationally contact the Patriarch's office of the Greek Orthodox Church and brief whomever they have a comm line to about the concern raised by Alevizopoulos and the KYP report.

10. At the second interfaith meeting, brief all religious groups in attendance on the implication of the KYP report. Show how Alevizopoulos is trying to create a rift between the Orthodox Church and other religious groups and why he should be removed from his post. Get them to originate what they can do to handle this situation. Find out what comm lines they have which they could use to handle this situation.

11. Get their originations pushed through to done.

DSA PR Greece

12. If no Catholic or Jewish or other mainline churches initially become part of the interfaith group, find a comm line to these religions, meet with them and show them how they are also attacked in the KYP report. Get them to take actions against Alevizopoulos and put pressure on the Greek government and the Patriarch of the Orthodox Church to get this handled.

13. Meet with politicians who could help on this matter such as the Minister above Human Rights, the Minister of Foreign Affairs, the Minister of Education, etc, and brief them on what Alevizopoulos and Seraphim are trying to do. Get them to take a stand on the issue and raise the matter with the Patriarch or with another terminal in the government to ensure the government does not get involved in religious matters. Establish such a comm line to these terminals so that they will report information on any new laws being pushed to "regulate" new religious movements and will contact you should they hear of such laws.

14. In coordination with the A/PR Aide OSA EU, get onto the EU interfaith comm lines to get thea briefed on the KYP report. Get them to put pressure on the Patriarch of the Greek Orthodox Church in regards to this KYP report and Alevizopoulos and point out how anti-religious it is.

15. Concurrently, survey the community to find out what community activities the Church should be involved in that would create a religious image for the Church and that would DA the enemy lines that Alevizopoulos and Seraphim have been spreading on "cults" over the past months.

16. In coordination with the PR Pgms Execution Off OSA Int, write a PRAC program based on these results which you can execute with the help of volunteers. Ensure the program includes targets to hold events and get media made regularly.

17. Execute this prograr.

18. Get Public Record Research dene on Seraphim and Alevizopoulos. Get this fully researched, including listing the friends and opponents with their names and functions, from newspaper articles, brochures, debrief of visits etc. Include studying the articles which were printed about the KY? report and note down the names of scholars and constitutionalists who expressed themselves against this report. Report the results to the Public Records Research I/C CSA Int.

19. Get a criminal mind analysis dene on Alevizopoulos.

DSA Greece

20. Get a PI to investigate Seraphim and Alevizopoulos as to their personal activities to find out any crimes they are involved in. Ensure that any connections with ARM terminals in Germany are well documented.

21. Compile a DA pack on Alevizopoulos using the documentation available. Include the data about the people he invited to the Nov 93 conference which will prove he is -dealing with very doubtful people whom the Orthodox Church would want nothing to do with. Include the KYP report and opinion leaders who spoke out against it.

22. Through public record research and debriefs of visits, find the right terminals and lines in the Holy Synodus to put the DA pack on to get this ecclesiastical body to conduct their own investigation into Alevizopoulos, and get the DA pack given to these terminals.

23. Utilize the data gotten on invest lines to expose the criminal activities of Alevizopoulos and Seraphim.

24. Use allied/invest lines within Germany to determine the exact extent of coordination/activity ongoing between Germany and Greece and its predicted path/key figures.

25. Coordinate with the Invest Off Germany on the execution of target 8 of the Lutheran Estimate program covering the investigation and discrediting of the president head of EZW (Evangelical Center on Ideological Questions of the German Lutheran Church.)

26. Once done, in coordination with the Invest Off Germany, get this exported to Greece to get support and allegiance lines cut from the Orthodox Church.

27. Set up lines in Greece into the ARM group so that we can identify those involved and work out individual handlings.

28. In coordination with the Invest and Pred Chf OSA EU, get the Greek intelligence (KYP) Report translated so that it can be exposed and used internationally to embarrass the Greek government and those in the Orthodox Church who are behind this.

29. In coordination with the A/PR Aide OSA EU, get the KYP Report brought to the attention of international religious bodies, EU Human Rights Commission, the Catholic, Jewish and other mainline Churches attacked in the report, with flanking media to expose this fascist trend.

30. Get legal research done on anti-proselytism laws in Greece and how this can be challenged (off our ground if possible - ie, via another religion), to cancel it and then obtain religious status for Scientology in Greece.

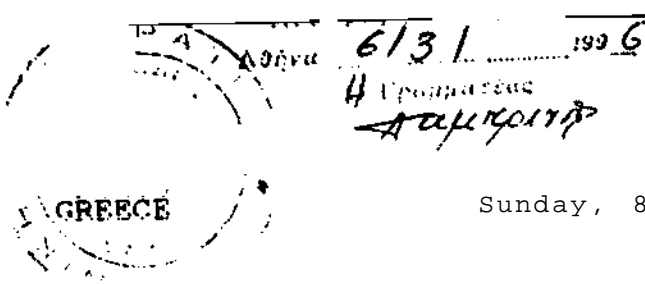
